Although the Port will endeavor to provide copies of this Addendum to all Prospective Bidders, it shall be the responsibility of the interested Prospective Bidders to advise all Parties (including Subcontractors) affected by the modifications or interpretations included in this Addendum.

1.0 General

- 1.1 Section 00200, Notice to Contractors – Due to the unprecedented circumstances involving the COVID-19 pandemic, the following protective measures shall be required. Each Prospective Bidder that would like to attend the mandatory pre-bid meeting will be required to wear a mask, at his or her expense. The Port will not provide any personal protective equipment. Each Prospective Bidder shall be required to follow all social distancing guidelines. Those refusing to comply with the social distancing guidelines will be asked to leave rendering them unable to bid on the project.
 - 1.1.1 Each Prospective Bidder shall be able to satisfy the screening questions and temperature (no fever) reading as shown on the attached Port questionnaire (see attached COVID-19 and Infectious Diseases Screening document). If the person cannot satisfy the screening questions, the Prospective Bidder will be asked to leave resulting in the disqualification to bid on the project.

Screening Questions:

- #1 "Yes" or "No" Answers Desired - Have you had any of the following in the past three days?
- A new fever (100.4°F or higher), or a sense of having a fever?
 - A new cough that you cannot attribute to another health condition?
 - New shortness of breath that you cannot attribute to another health condition?
 - A new sore throat that you cannot attribute to another health condition?
 - New muscle aches (myalgias) that you cannot attribute to another health condition, or that may have been caused by a specific activity (such as physical exercise)?
- #2 Are you unable to hold your breath for 10 or more seconds?
- #3 Have you traveled internationally or to a densely populated area of the United States in the past 14 days?
- #4 Have you been in the presence of someone who has tested positive for Covid-19 or another infectious disease in the past 14 days?
